"5,000-gallon or greater capacity"
Capacity is 445 gallons, per the [product specs](#)

"24-inch or greater in depth"
External height is 38"; external depth of the unit (less the feet) is 34"; I don't have the internal depth.
I've attached a doc with dimensions

"hard-wired electrical connection"
The connection will be hard-wired from the hot tub to the control panel.

Hello Joe Blotner,

Thank you for your application. Please note your project has exemption thresholds that may or may not require a permit.

The exemption thresholds are 5,000-gallon or greater capacity, 24-inch or greater in depth and have a hard-wired electrical connection. If any of these thresholds are exceeded, a permit is required unless it is portable and requires no electrical work.

Can you please confirm if you exceed any of the above thresholds? If yes, we will process your permit application as accepted.
